MANAGEMENT LETTER

In planning and performing our audit of the financial statements of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of the Maverick County, Texas (the "County") as of and for the year ended September 30, 2013, in accordance with auditing standards generally accepted in the United States of America, we considered the County's internal control over financial reporting (internal control) as a basis for designing our auditing procedures for the purpose of expressing our opinions on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the County's internal control. Accordingly, we do not express an opinion on the effectiveness of the County's internal control.

However, during our audit we became aware of several matters that are opportunities for strengthening internal controls and operating efficiency. The memorandum that accompanies this letter summarizes our comments and suggestions regarding those matters. (We previously reported on the County's internal control in our report dated March 18, 2015. A separate report dated March 18, 2015, contains our report on significant deficiencies and material weaknesses in the County's internal control.) This letter does not affect our report dated March 18, 2015, on the financial statements of the County.

We will review the status of these comments during our next audit engagement. We have already discussed many of these comments and suggestions with various County personnel, and we will be pleased to discuss them in further detail at your convenience, to perform any additional study of these matters, or to assist you in implementing the recommendations.

STATUS OF CURRENT AND PRIOR YEAR COMMENTS

There are no new comments proposed for the year ended September 30, 2013. There were two comments that were repeated from the County's management letter dated March 17, 2014, which are below.

Investment Policy

During our audit, we noted that the County does not perform an audit of management controls on investments and compliance with the County's investment policies as required by the Public Funds Investment Act.

Status:

This finding was repeated in the current year.

Single Audit – Reporting

During our audit of the Stone Garden grant, we noted that the County was a sub-grantee and was not responsible to submit financial reports. However, the County was required to submit quarterly progress report. We determined through verification with the pass through entity that the County had complied. However, the County had no in-house records to demonstrate compliance.

Status:

This finding was repeated in the current year.
