

Survey, the Cortez Fielder Survey No. 70 and the Serena Goodrich Survey No. 71, described in a deed from Carlos J. Klutts to Lampasitos Land, Ltd., dated Feb. 17, 2010, recorded in Book 1222, Pages 173-177 of the Official Public Records of Maverick County, Texas. Herein described tract or parcel of land being more particularly described by metes and bounds as follows:

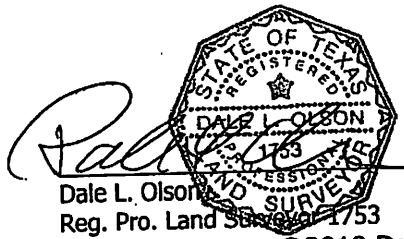
COMMENCING for reference at the northwest corner of the said 1531.049 acre tract, a 5/8 inch iron rod found at a fence corner, the northeast corner of that certain 650.926 acre tract described in a deed from Barns Brother Farm LLC, to Winn Exploration, Co., Inc., recorded in Vol. 586, Page 150, Maverick County Deed Records, the northeast corner of Survey No. 23 and southeast corner of Survey No. 19 and southwest corner of Survey No. 18 and northwest corner of said Survey No. 71.

THENCE with the west line of the 1531.049 acre tract and Survey No. 71, the east line of the Winn 650.926 acre tract and Survey No. 23, S 00 deg. 01 min. 10 sec. E, 595.96 feet to a 5/8 inch iron rod set for the POINT OF BEGINNING, the northwest corner of this tract.

THENCE S 67 deg. 25 min. 20 sec. E, 1470.66 feet to a 5/8 inch iron rod set in the center of a cul-de-sac of a 60 foot access easement for the east corner of this tract, from which a 5/8 inch iron rod set for reference bears N 67 deg. 25 min. 20 sec. W, 60.00 feet.

THENCE S 61 deg. 50 min. 18 sec. W, at 60.00 feet pass a 5/8 inch iron rod set for reference, in all 1539.79 feet to a 5/8 inch iron rod set in the west line of the 1531.049 acre tract and Survey No. 71, the east line of the Winn tract and Survey NO. 23, for the south or southwest corner of this tract.

THENCE with the west line of the 1531.049 acre tract and Survey No. 71, the east line of the Winn tract and Survey No. 23, N 00 deg. 01 min. 10 sec. W, 1291.36 feet to the POINT OF BEGINNING, containing 20.126 acres of land.
